Explanation of Responses:

- Mr. Tomasi was awarded 344,060 restricted stock units ("RSUs") pursuant to the Company's 2018 Equity Incentive Plan on February 25, 2022, of which, 25% will vest on March 1, 2023, and the remainder of the RSUs will vest in 12 equal installments on each three month anniversary thereafter, subject to Mr. Tomasi continuing as a Service Provider through each such date.
- Each RSU represents a contingent right to receive one share of Common Stock of the Issuer.
- Includes shares of common stock purchased under the Company's 2018 Employee Stock Purchase Plan.
- Includes 3,953 shares received as a pro-rata in-kind distribution of Common Stock of the Issuer by Alta Partners Management VIII, LLC (APM VIII), without consideration, to the reporting person as a non-managing member of APM VIII.
- The shares are held by Mr. Tomasi and Carrie Tomasi, as Trustees of the Tomasi Living Trust dated July 14, 2017.
